

## \$100 NDB Bonus

  - 2.3 If the client successfully trades **five (5) standard lots**, they will be eligible to withdraw profits generated from the trades (minimum \$100 up to a maximum of \$1,000).
- 3. **Eligible Account Types:** All account types are eligible for the Promotion.
- 4. The bonus will be automatically reflected in MT4 & MT5 after the deposit. It can be used for 30 calendar days from the day it is deposited into the client's account. At the end of the 30-day period, the bonus will be deducted from the account along with any unclaimed profits made using the bonus.
- 5. Trades executed through promotion accounts are not eligible for IB commissions.
- 6. **IB commissions** will only be provided **after** an additional deposit has been made.
- 7. **The NDB bonus cannot be applied** to an account where other bonuses have already been granted. However, once the initial deposit is made in this account, participation in other promotions will be possible.
- 8. Tradable Instruments: Forex, CFD, Indices, and Stocks.
