

## Land prime USA Lottery Giveaway Promotion

Land Prime Ltd ("Landprime") is launching the USA Lottery Giveaway Promotion ("US Lottery"). During the event period, all qualified clients ("clients") will receive US Lottery tickets based on deposit amount and traded lots.

The terms and conditions outlined below form the basis of participation in the US Lottery. Every client participating in this program must follow the rules detailed in these terms and conditions. It is important to read and fully understand all of them.

## **Terms & Conditions**

- 1. To participate in the US Lottery, clients must verify their KYC documents and have a fully activated live account. Qualified clients must hold a POA/PLE from Vietnam, Thailand, the Philippines, or Japan.
- 1.1 Clients with a funded Live account have full access to the program.
- 1.2 Clients with only demo accounts or unfunded live accounts do not have access to the program.
- 2. Promotion Period: October 21, 2024, 00:00 ~ December 27, 2024, 23:59 (Landprime Server Time, GMT)
- 3. US Lottery Points will provide as follows:
  - 3.1 All account types with Landprime are eligible to earn US Lottery Points, except for the ECN and Cent Account types.
  - 3.2 US Lottery Points will be credited to the NDB account once the client makes a deposit into the NDB account.
- 4. US Lottery Points earned can be accumulated and will expire when the promotion ends.
- 5. US Lottery Points collected during promotional campaigns are subject to the terms and conditions of the promotion.
- Landprime reserves the right to deduct or cancel any points if it has reasonable grounds to believe that a client is not acting in good faith, is not in compliance with any general terms and conditions, or is involved in any suspected abuse or fraudulent practices.

- 7.1 To receive US Lottery tickets:



- The minimum required deposit amount to join US Lottery promotion is \$100.
- A trading volume of 2 lots in Forex or Gold will earn one US Lottery ticket. (Only trading operations opened and closed during the promotion period are considered.)
- Trading volume will be assessed weekly, and the volume will reset for the next week.
  - 7.2 A maximum of 5 US Lottery tickets can be opened per week; any remaining trade volume will not carry over to the next week.
  - 7.3 Once clients meet the required deposit amount and trading volume, they can open up to 5 US Lottery tickets per week manually or randomly on the mypage.
  - 7.4 Lottery applications are accepted throughout the event period. However, applications must be submitted before 00:00 GMT on Friday to be considered for that week. Applications submitted after the deadline will be entered into the following round.
  - 7.5 The results of the lottery rewards will be based on the Saturday USA Powerball numbers. The results will be available for review on your mypage the following Monday.
  - 7.6 LandPrime is authorized to disqualify any participant in the promotion who intends to abuse, arbitrage or violate the promotion terms and conditions, and further reserves the right to amend or terminate this promotion at any time. Any amendment or termination of the promotion will be subjected to notifications from LandPrime.
  - 7.7 If LandPrime suspects or has reason to believe that client is set under 7.6 cases, Land Prime is entitled as its sole discretion to:
    - 7.7.1 Deny, withhold or withdraw deposits from client's account(s) and/or from any other account(s) related to such client's account.
    - 7.7.2 Withhold, cancel and subtract from client's account(s) and/or from any other account(s) related to such client's account.
    - 7.7.3 Offset any resulting of profits/losses from related account(s).
    - 7.7.4 Terminate client's any services and contracts provided by LandPrime.
    - 7.7.5 Block client's account(s) by maintaining minimum regulatory requirements.
    - 7.7.6 Cancel profits, Introducing Broker (IB) commissions.
  - 7.8 LandPrime will not inform to client regards to investigation details for abusing account.
  - 7.9 LandPrime reserves the right of final interpretation of this promotion.
